### **2.1 About the City of Tashkent Uzbekistan**

Tashkent, or Toshkent in Uzbek is the capital and largest city of Uzbekistan. It is the most populous city in Central Asia with a population of more than 3 million people (about the population of Arkansas) as of April 1st, 2024. It is in northeastern Uzbekistan.



### **2.2 How to get to Tashkent**

The most convenient way to get to Tashkent is by plane. The city's airport is Islam Karimov Tashkent International Airport (TAS) and has many international and domestic flights.

Tashkent is a major stop on the Central Asia Train Network. You can take trains from Russia, Kazakhstan, and other cities to Uzbekistan. You can drive to Tashkent from neighboring countries, but it can take hours to clear customs. The M39 connects Tashkent with Samarkand and the A2 connects Tashkent with Kazakhstan.

### **2.3 Weather of Tashkent in May**


The average high temperature in Tashkent in May is 27°C.

Only those athletes having their documents uploaded until the end of registration and having an eligible impairment may be moved from the "waiting list" to the actual list of registered athletes for the event. An athlete without an eligible impairment for Para-Karate will not be moved from the waiting list.

The Head of Para Karate classification can ask for supplemental medical documentation to prove the underlying health condition of the athlete. The mandatory forms can be found at the following links:

All documents MUST be attached in English for ALL registered athletes. All MDFs must be completed by a registered Medical Doctor, M.D.

All athletes must attend the classification session on **Friday, 23 May at the HQ Hotel, between 10:00 – 18:00 - the schedule of the classification session will be published online one day before the classification session.**

Please see the Para Karate registration checklist before the completion of the registration of the Para Karate athletes.

**Para Karate Athletes per Category**

Every nation has the opportunity to register three (3) Para-Athletes per sport class. In total, 24 athletes can be called by each nation.

**Classification Session**

Classification in Para Karate consists of extra point compensation in K10 and K30 sport classes depending on the influence of the particular impairment when performing the Kata. Detailed information can be found in the Para-Karate regulations:

Registered Para-Karate athletes must present themselves for a mandatory on-site Classification Session performed by qualified personnel before the championships.

### **3.12 Coaches and Personal Assistant**

A maximum of One (1) Coach can be registered for Para-Karate per Nation. Every Para-Karate athlete can be accompanied by a personal assistant during their performance on the field of play. This means One (1) personal assistant per Para Athlete.

Coach and assistants accompanying Para-Karate athletes MUST register together with their delegation at the onsite registration session only. All Para Athletes must use the same sportswear and equipment for classification as they use during the competitions.

Concerning athletes with visual impairments, no extra testing will be performed during the classification session. Nevertheless, the athletes have to show up to the classification with the documents and equipment mentioned above. Extra

points will be given based on the Medical Diagnostic Form

## 4. Referee & Coach Programs

All NFs participating in AKF Championship shall be obligated to send qualified referees to officiate. The minimum qualification of the referee to be sent by the NFs is AKF Kumite RA / Kata JA. The number of referees to be sent by NFs for officiating in the Championship shall be according to the number of athletes from the NF participating in the Championship as follows:

If the NF cannot comply with the minimum referee license requirement, then the NF shall be liable to pay a levy of \$100 USD per referee short. This amount shall be payable to AKF Treasurer during the onsite registration. There shall be no limit to the numbers of referees sent by the NFs for officiating in the Championship. However, at any one time, there shall be no more than 8 referees officiating at the same time.
